



Review of Arizona Revised Statutes Containing A Felony Criminal Penalty

Criminal History Project Overview

As part of the Arizona Criminal Justice Commission's (ACJC) work as required by A.R.S. §41-2405, Section A, the Commission is to:

- Monitor the progress and implementation of new and continuing criminal justice legislation;
- Analyze criminal justice programs created by the legislature in the preceding two years; and,
- Analyze the effectiveness of the criminal code, with a discussion of any problems and recommendations for revision if deemed necessary

At the direction of the Commission, ACJC's Statistical Analysis Center (SAC) along with program staff undertook a review of those Arizona Revised Statutes that contained a felony criminal penalty to determine the frequency of statute charges at the time of arrest across five-year, ten-year, and 15-year periods. Staff reviewed an extract of the Arizona Computerized Criminal History (ACCH) repository, maintained at the Arizona Department of Public Safety (DPS), to capture arrest charging frequency across Arizona Revised Statute criminal codes.

Key Findings

The resulting data span from Fiscal Year (FY) 2002 to FY 2016 for a total of 15 years provided the following key findings (see overview on page 3):

- There are 1,487 individual statutes that contain a felony criminal penalty currently chargeable by Arizona law enforcement across nearly every A.R.S. Title
- 500 of the 1,487 statutes (34 percent) have no arrest charges recorded in the ACCH over the previous fifteen years
- Several A.R.S. Titles have a very high percentage of statutes with a felony penalty that have not been charged in the past 15 years:
 - Title 20 – Insurance (23 out of 32)
 - Title 32 – Professions and Occupations (84 out of 103)
 - Title 33 – Property (2 out of 2)
 - Title 34 – Public Buildings and Improvements (2 out of 2)
 - Title 35 – Public Finances (8 out of 12)
 - Title 38 – Public Officers and Employees (16 out of 20)
 - Title 39 – Public Records, Printing and Notices (3 out of 4)
 - Title 40 – Public Utilities and Carriers (7 out of 7)
 - Title 41 – State Government (28 out of 42)
 - Title 43 – Taxation of Income (1 out of 1)
 - Title 44 – Trade and Commerce (66 out of 89)
 - Title 45 – Waters (3 out of 3)
 - Title 46 – Welfare (5 out of 9)
 - Title 49 – The Environment (47 out of 54)
- 78 of the statutes that have become effective since June 2011 have no arrest charges as recorded in the ACCH as of the end of FY 2016.

Expected Outcomes

The Arizona Criminal Justice Commission hopes that this report outlining those Arizona Revised Statutes that contain a felony criminal penalty and their use over the past 15 years will spark a dialogue by Arizona's legislators and policy makers about the increasingly complex landscape that has been created for Arizona citizens and law enforcement to navigate regarding illegal activities.

Possible activities that could occur include:

- Convening of stakeholder groups that deal with specific issue areas to review existing statutes that contain felony penalties to determine if they are still applicable and necessary
- Review by the legislature to determine if penalties contained in one statute are duplicative of penalties contained in another (for example is A.R.S. §5-115A2, Bribe of Racing Personnel is a class 4 felony and has not been charged in the past 15 years, but A.R.S. §13-2309, Bribery of Participants in Professional or Amateur Games, Sports, Horse Races, Dog Races, Contests is also a class 4 felony and is regularly being charged)
- Action by the legislature to repeal statutes that are determined to be duplicative or have not been utilized after a specific period of time has elapsed

REVIEW OF ARIZONA REVISED STATUTES WITH A FELONY PENALTY

Data Methodology

The Arizona Criminal Justice Commission's Statistical Analysis Center (SAC) used an extract of the Arizona Computerized Criminal History (ACCH) repository, maintained at the Arizona Department of Public Safety (DPS), to capture arrest charging frequency across Arizona Revised Statute criminal codes. The resulting data span from Fiscal Year (FY) 2002 to FY 2016 for a total of 15 years. Data tables review the frequency of statute charges at the time of arrest across five-year, ten-year, and 15-year periods.

According to the on-going data sharing agreement, the DPS provided to the SAC all arrest and subsequent case disposition data housed in the ACCH repository dating back to fiscal Year 2002. Columns within the tables are broken down into the following categories-

Green Column = At least one arrest charge over the previous five years AND/OR the statute went into effect within the past five years

Yellow Column = At least one arrest charge over the previous ten years AND no arrest charges in the previous five years

Orange Column = At least one arrest charge over the previous fifteen years AND no arrest charges in the previous ten years

Red Column = No arrest charges over the previous fifteen years AND the statute has been in effect for at least five years.

While the ACCH repository is a valuable source of arrest information, there are some caveats to the data that must be recognized. The following outline these limitations to the data-

- 1) All felony offenses and misdemeanor DUI, sexual and domestic violence-related offenses are mandated to be entered into the ACCH repository at time of arrest. While many of the approximately 140+ arresting agencies across Arizona are entering all felony and misdemeanor booking information through the Livescan machines, it is unclear the full magnitude of agencies across the state that have adopted this more inclusive process. This report reviews felonies only because it is unclear just how many non-statute mandated misdemeanor charges are voluntarily reported to the ACCH repository each year.
- 2) Arrest information only goes back to FY 2002. Per the current data sharing agreement, the DPS provides ACCH data dating back to January 1, 2002.
- 3) Arresting agencies do not always charge to the appropriate subsection of the criminal statute. For example, an arresting agency may enter an assault as "13-1203" rather than "13-1203.A1."
